Establishment of Interest Lists for the Project Based Voucher Program

Fresno Housing manages the Project Based Voucher (PBV) program for the City of Fresno and the Fresno County Housing Authorities. Project-Based vouchers are a component of the Housing Choice Voucher (HCV) Program and are tied to specific units at a complex rather than being tied to the family. The PBV program provides rental assistance to eligible low-income individuals and families, which helps them afford safe, quality housing. Fresno Housing will be opening its Interest Lists to accept pre-applications for multiple PBV housing complexes. Each complex has its own separate criteria and qualifications an applicant must meet.

The Interest Lists below will open <mark>Wednesday, August 16, 2023</mark>, at 8:00 a.m. and close <mark>Wednesday,</mark> <mark>September 6, 2023</mark>, at 5:00 p.m.

The interest list will remain open for limited preference and referral-based programs only.

Bedroom size(s): 2 bedroom units. **Minimum Qualifications**: Head of household, co-head and/or spouse, must be at least 62 years old. Income limits apply.

Citrus Commons – 201 Citrus Ave, Orange Cove, CA

Currently Under Construction

Bedroom Size(s): 2, 3, and 4 bedroom units.

Minimum Qualifications: One member in the household must be an agricultural worker. Agricultural worker means an individual who receives, or prior to retirement or disability, receives a substantial portion of his/her income from agricultural employment. Income limits apply.

Corazon De Valle Commons – 17153 Fresno Street, Huron CA

Currently Under Construction Bedroom Size(s): 1, 2, 3, and 4 bedroom units. **Minimum Qualifications**: Income limits apply.

ADDITIONAL INFORMATION

- Allow one week after submitting your pre-application to log into your account or call 441-2318 to view your status or update changes.
- Report all address/contact changes within 10 business days of the change.
- The applicant will receive a confirmation email or letter when applying.
- There is no charge to submit a Project Based Voucher pre-application.
- Only one pre-application per household is allowed. Duplicate pre-applications will not be accepted and will only delay the process.
- Applicants must be income eligible and pass a criminal background check at the time they are selected from the Interest List. Income limits are posted on the website at www.fresnohousing.org
