There was a duly noticed meeting of the Executive Committee of the Boards of Commissioners of the Housing Authority of the City and County of Fresno which met on August 8, 2023, at Fresno Housing Board Room located at 1331 Fulton Street Fresno, CA 93721.

1. The meeting was called to order by Chair Catalano at approximately 5:19 p.m., and members present and absent were as follows:

#### a. Governance Matters

Cary Catalano, Board Chair, presented on this item.

Board structure history needs to be researched and a meeting set up to discuss why we are structured currently as city and county.

Chair Catalano advised after speaking with Mr. Pacheco, that there may be 2 candidates being considered for the 2 County Board vacancies, one from Firebaugh and one from Mendota.

October agenda based on by-laws city board nominations should be added.

Annual CEO evaluation is underway and will be presented in closed session at the September 26<sup>th</sup> Joint Board Meeting. Cary gave some insight as to what the commissioners can expect and the timeline for completing the evaluation. We expect to ratify the evaluation at the November 14<sup>th</sup> Joint Board Meeting.

#### b. Administrative Matters

Tyrone Roderick Williams, CEO, presented on this item.

- Continuing to review and update agency policies.
- Consideration policies will be taken to the joint board meeting
- Jeff shared regarding COVID-19 and reporting instructions.
- Marcellino Rodriguez from Property Management will be retiring after 23 years. We will acknowledge him at the September 26<sup>th</sup> Joint Board Meeting.
- In addition to the auditing, we are in the middle of the budget review process and a presentation will be brought to the September Joint Board meeting. CalPERS and Benefit costs are key issues being addressed due to the amount of increase and its impact.

#### c. Executive Director Update

Tyrone Roderick Williams, CEO, presented on this item.

- HUD Visit with Fiona Ma went well.
- La Joya Commons in Firebaugh groundbreaking date has been moved to 10/17/23 at 11 am.
- During the director's report at the September Joint Board meeting, Mr. Williams plans to do a presentation to recap Agency Goals and where things stand.
- Several awards were won and will be received at NAHRO.
- Tammy shouted out Marc' for writing and submitting our Agency for awards given at NAHRO.
- Mr. Williams recapped a few agency goals as well as the rebranding of Ed Corp.
  A consultant team has been hired and some of their achievements will be highlighted at the September Joint Board meeting.
- We have been asked by Fresno Unified Students to submit a proposal to them. FHA would be the first agency to submit a proposal that would be broad.
- An additional proposal will be submitted to the US Dept of Congress on 10/15/2023 in partnership with Workforce Development. There are 2 awards, a \$250,000 planning grant and a \$20M implementation grant which represent a historic shift for this agency.

#### d. HCV Status and Events

Tyrone, presented on this item.

- The landlord incentive program is finding more landlords. The team and partnership with the city are paying off but still in the middle of a housing crisis.
- More funds are being drawn to keep up with the rent increases. We have been in touch with HUD to ensure what we need to continue making HAP payments to landlords. This impacts the time the public is on the waitlist for vouchers.

Michael Duarte, Chief of Real Estate Officer, presented on this item.

- La Joya Commons we were pending building permits, we have received those.

- Step Up (Manzanita Commons) We have been dealing with restricted covenants there, and approached it through a streamline bill (AB721) which allows modifications to the restricted covenants which was a success. Investors want a legal opinion.
- Pine warehouse under contract, extension signed but good possibility it will be sold next week.
- Senate Bill 469 signed 09/08/23 signed by the governor. It eliminated Article 34 restrictions related to affordable housing development.
