#### a. Governance Matters

- Tammy presented the findings on the 1995 JPA Agreement that outlined the reasons our board is structured the way it is. Chair Catalano added that after discussing the board structure with Mr. Jim Petty he advised the reasons why the board structure is as it is. One reason provided was to eliminate duplicated efforts in terms of staff time because there were 2 separate board meetings so having one board meeting and collaborative conversations was the goal. Mr. Jim Petty advised that the City and the County would have to agree to change the board structure and get rid of the two votes.
- Tammy reviewed the 2024 draft Agency Calendar and asked for any feedback or recommendations. Chair Catalano suggested the Board Retreat be added to the Agency Calendar before it is finalized and voted on at the upcoming Joint Board meeting.
